

# CERTIFICATE OF CONFORMITY TO THE IFRA STANDARDS

## BASIS OF ASSESSMENT

The complete formula of the fragrance compound (every material and its percentage) was assessed at 21 % w/w in the finished product against the IFRA Standards up to and including the 51st Amendment for Category 4. Each material was matched to the IFRA Standards by CAS number and name (including trade names and dilutions), contributions of restricted constituents from natural complex substances were added using the IFRA Annex on contributions from other sources (51st Amendment), rose ketone and methyl ionone isomers were summed, and each resulting level in the finished product was compared with the Category 4 limit. Prohibited materials were checked as added ingredients and, for natural-source traces, against the IFRA note limits.

## IFRA-RESTRICTED, SPECIFIED AND PROHIBITED MATERIALS

The fragrance compound triggers 34 IFRA Standards (restrictions and specifications), including contributions from natural complex substances per the IFRA Annex on contributions from other sources. Each was assessed quantitatively at the stated concentration and every one is met for Category 4.

The itemised assessment (materials, levels and limits) is commercially confidential and is held on file by Scent Room; it is available to a regulator, or to a customer under a confidentiality agreement, on request.

## PROHIBITED MATERIALS

No material listed as prohibited by the IFRA Standards is added to the fragrance compound. Trace constituents of natural complex substances that are the subject of IFRA note limits (for example benzyl cyanide, safrole, 7-methoxycoumarin, isophorone and asarone) have been quantified in the assessment on file and are within those limits.

## DECLARATION OF CONFORMITY

Scent Room declares that the fragrance compound used in Scent Room Bitter Peach Extrait de Parfum (SR-EDP-BITTER-PEACH-100ML), at 21 % w/w in the finished product, has been assessed quantitatively against the IFRA Standards up to and including the 51st Amendment for IFRA Category 4, and that every restricted material is within its Category limit, every specification is met, and no prohibited material is present. This declaration is made on the basis of full knowledge of the formulation and the IFRA Annex on contributions from other sources.

## EU ALLERGEN DECLARATION (FOR LABELLING)

Allergens on the EU cosmetic declaration list (Regulation (EU) 2023/1545) present at or above 0.001 % in the finished product, to be named on the label: Tetramethyl acetyloctahydronaphthalenes (Iso E Super); Linalool; Hexamethylindanopyran; Citrus peel oil; Vanillin; Pogostemon cablin (patchouli) oil; 3-Methyl-5-(2,2,3-trimethylcyclopent-3-en-1-yl)pent-4-en-2-ol (Ebanol); alpha-Isomethyl ionone; Coumarin; Benzyl alcohol; Jasminum absolute; Cedar oil (Cedrus / Juniperus); Camphor; Damascenone (rose ketone); Evernia prunastri (oakmoss) extract; Pelargonium (geranium) oil; Citronellol; Cananga odorata / ylang ylang oil; Benzaldehyde.

This certificate applies to the formulation and concentration stated. Any change to the formula, concentration, product type or application requires reassessment. The 52nd Amendment to the IFRA Standards is expected to be notified in late 2026; this certificate will be reviewed within the implementation period.
